How StorageX Manages Your Data

StorageX dynamic file management is powerful solution for managing your file storage resources based on industry standards. File management uses an automated, policy-based engine to ensure your file movement processes run smoothly and on schedule.

- Accelerate consumption of Compuverde software-defined storage using powerful analytics to quickly identify sets of matching shares/exports to be moved, consolidated, replicated and, or archived.
- Automated data movement policies facilitate the transfer, archival, or replication, of SMB/NFS source files across heterogeneous storage resources. Move and consolidate an entire share or export to new Compuverde storage.
- Cutover Estimation estimates data movement time. Use to decide when "cutover" will occur, or when you will stop sharing the source and start redirecting users to the file data in the new location.
- Automated access control security management for Software Identifiers (SIDs). Make changes to SIDs, remove orphan SIDs and preserve SIDs during file movement.

Compuverde is a fully software-defined storage solution that gives you not only a SAN or an object storage, but also a fully featured file system for applications, clients and operating systems using SMB or NFS. It can be deployed using bare-metal servers or virtualized servers with storage and compute on the same server nodes. It also simplifies your data center planning – you can start with as small as a four-node cluster and then expand, as needs emerge, to hundreds of nodes, exabytes of data, a Metro Cluster with two synchronous datastores across a metropolitan area, or Compuverde Hybrid Cloud for shared storage and disaster recovery.
